COURT FEES AND ENDORSED COSTS

The fees payable, and endorsed costs claimable, in Supreme Court proceedings from 1 July 2023 are attached.

The fees prescribed in various rules and regulations applicable to Supreme Court proceedings are set by reference to "fee units" under the *Fee Units Act* 1997. The value of a fee unit has increased to \$1.78 from I July 2023.
