# CRIMINAL CASE MANAGEMENT LIST DATES 2025 AND 2026 AND CIVIL MISCELLANEOUS LISTS

This Circular replaces Circular 15 of 2024 and Circular 5 of 2023. The dates provided in Annexure A apply to committals made from 14 July 2025.

The Associate Judge now exercises both civil and criminal jurisdiction (refer s 372 *Criminal Code Act* 1924). With some exceptions the Associate Judge will case manage criminal matters from the point of committal to the Supreme Court until the matter is heard by a judge.

The Associate Judge will sit weekly in the criminal jurisdiction to deal with first and subsequent appearances until a matter is ready for trial, or otherwise needs to be listed before a judge.

The Associate Judge will run a Criminal Case Management List (CCML) in place of the "remand day" arrangements that have been in place in the past. The CCML is for all types of criminal appearances before the Associate Judge, not only first appearances.

The dates of the CCML for 2025 and 2026 for each registry are set out in **Annexure A**. The Magistrates Court should commit matters to a date for a first appearance that is at least seven weeks after the date of committal.

There will be no CCML between the end of the Eighth Sittings in 2025 and the First Sittings in 2026. To avoid too many matters being committed to the first CCML in 2026 from the end of October 2025 until 15 December 2025 the Magistrates Court will be asked to commit to a nominated date. The first appearance dates for committals during that period are set out in **Annexure B**. In 2026 a further series of dates will be provided for the period October – December 2026.

Hobart - Appearances by defendants on bail will be listed for 9:30am.

Launceston – CCML will be at 11am, usually from Court 2 by video link to Hobart.

Burnie – CCML will be at 9:30am, from Court 1 by video link to Hobart.
